Filing of a Declaration of Use Under Section 8 or Combined Declaration of Use in Commerce and Incontestability Under Sections 8 & 15

We will file the required Declaration together with a Power of Attorney and Change of Correspondent Address, if necessary. Our fixed fee for this service is \$235.00 for one class and \$145.00 for each additional class in the same application plus the USPTO fee.

The following are included in our fixed fee:

- Preparation of the required Declaration
- Submission of the Declaration to the USPTO

Filing a Combined Declaration of Use In Commerce under Sections 8 & 9 (Renewal)

Filing of a Foreign Application, per country

- Receipt of communications from foreign associate

- Transmittal of registration certificate, if provided by foreign country

Wire and currency conversion fees are billed at cost.

Our fee does not include foreign government office fees and foreign associates' fees, which vary by country.

Refusal for Other Reasons

In addition, we will respond to US Office Actions citing any cause for refusal of the Trademark Application, Declarations of Use, Combined Declarations of Use and Incontestability, or Renewals. Responses are billed at an hourly rate of \$250.00.

Opinions

We provide opinions of registrability and use of the proposed trademark based on the search report. The opinion will consider issues of likelihood of confusion and other potential refusals.

Opinions start at \$175.00. The final fee is based on the amount of time necessary to review the report and formulate and prepare the opinion.
